Dear Parent/Guardian:

This letter contains important information regarding transportation for Private & Parochial Schools, as well as Daycare Requests. Please know that according to Education Law, all requests for Daycare Transportation and Private & Parochial Transportation must be submitted for each school year.

Requests for **Private and Parochial Transportation** must be **received** by **April 1**<sup>st</sup> of the preceding school year. If you are unsure of what school your child will be attending, please fill out a form for a school you may be considering. Your child can always be removed at a later date.

All requests for Daycare must be received by August 15<sup>th</sup> to guarantee desired busing for the upcoming school year.

Please be sure to submit forms in a timely matter to ensure transportation. For your convenience forms are on the Transportation Section of the Washingtonville CSD (WCSD) website at <a href="https://www.wcsdk12.org">www.wcsdk12.org</a>. (Forms are also attached for easy access)

As a reminder the Washingtonville CSD does not transport on days when WCSD is not in session. (WCSD Board Policy attached) The WCSD 2024-2025 student calendar, outlining days the district is offering bus transportation, has been approved by the Board of Education and is attached. Please know that it can also be found on the district website in the upcoming months. Kindly check the website for updates.

Bus routes and bus stops shall be established annually by the Transportation Supervisor within the limitations of Board Policy and in conformity with school attendance areas and the maximum capacity of the buses to be used. Any requests for a change in bus route or bus stop must be submitted to the Superintendent or his/her designee.

Transportation services shall be provided to meet the needs of the students of the District within specified limits and areas established by the Board of Education. It is the intention of the Board of Education to have all (non-public) schools follow the Washingtonville Central School District calendar for transportation requirements. Therefore, the District will not transport students to nonpublic schools on days when District schools are closed, except as required by law. The District will notify nonpublic schools of the District's calendar for the following school year after approval by the Board of Education.

Wherever possible, bus routes will be limited to major public transportation arteries in the District and deviation from them will occur only when the location of bus stops would create a hazard to the bus and its passengers.

It shall be the policy of the Washingtonville Board of Education to review periodically, and revise where necessary, all bus routes so as to insure that the routes are planned in the most efficient and economical way possible.
